IMPORTANT INSTRUCTIONS TO BIDDER

1. The bidders shall closely peruse all the clauses of the tender documents and all annexure enclosed / referred in Tender Documents before quoting. If the bidder has any doubt about the meaning of any portion of the tender conditions, find discrepancies or omissions in the provisions, or require clarification on any of the technical aspect, scope of work etc. he shall at once contact the authority inviting the tender for clarification before the submission of the tender.
2. Non-compliance with any of the tender conditions set forth thereon and incomplete, conditional or ambiguous offers are liable to reject the tender.
3. Before submitting the bid, the bidders are advised to be well acquainted with the actual working and familiar with all other prevalent conditions, facilities available, nature of work / duties etc. No claim shall be entertained later, on the ground of lack of knowledge.
4. All entries in the tender documents should be in one color ink. Corrections, over writing, cuttings if any should be countersigned by the contractor with date. All the columns in the tender form should be filled without leaving blank in any clause in any page of the tender and all the pages must be duly signed & stamped by the bidder before submission. The contract can be extended further on mutually agreed terms and conditions.
5. The price / rate should be quoted in figure as well as in words. Price quoted in words shall be final and binding on all the parties. Price quoted shall be inclusive of all taxes & duties, all statutory requirement / liabilities etc. GST shall be extra as applicable.
6. Corrections in the bid should normally be avoided. However, when these become essential, bidder shall score out the incorrect information and put the correct information duly endorsing each correction with his signatures
7. **Procedure for Submission of Bid :** Above tender is “Two Part Bid” System (Technical / Commercial Bid & Price - bid). The tender is to be submitted in two parts.
 - a. Part I- Technical Bid (As per annexure G & I)
 - b. Part II- Price Bid (As per annexure K)

Part I:- The Techno-Commercial bid and its enclosures must be submitted in one sealed envelope super scribed as “**Tender No. 3295/Upeida/17/790 Dt. 08-01-2017**

TECNICAL BID” and due date EMD amount, and copies of all the relevant documents for qualifying requirement of the tender, must be enclosed with Part I.

Part II: The second envelope duly sealed should contain the **price bid** (Duly filled, signed and stamped in prescribed format as per annexure “K”) only. This envelope should be super

PRICE BID and due date. The price bid envelope should contain the rates in figure and words only. Any other enclosures, which the bidder wishes to submit, must be enclosed with the Technical bid only.

8. . The same should be dropped in the tender box kept in the office of UPEIDA, on or before the specified date and time.
9. Offer not in line with the above procedure or quoted in any other format is liable to be rejected.
10. **Opening of Bid:** The Technical bid shall be opened on specified date in presence of representatives of bidders who want to participate.
11. After evaluation of the Technical Bid, the price bids of only techno-commercially accepted bidders will be opened. The date of opening of price bid will be informed only to those bidders whose technical bid has been accepted for witnessing the Price Bid opening.
12. The bidders are required to quote the rates in Rupees per Kilometer (Rs./KM) in figures & words as well. There should be no cutting or over-writing in the price bid. Please ensure while filling the price bid.

Contactor’s Obligation

1. UPEIDA shall not entertain any claims arising out of increase in rate of Road Taxes, Permit Charges, Insurance charges etc.
2. Contractor shall supervise the work allotted to him and to be carried out by his employees.
3. **Maintenance of Log books:**

The contractor shall maintain separate logbook for vehicle. The logbooks shall have the details such as Date, Kilometer readings, places visited etc. shall be entered in the log books. The logbook should be verified by hospital and got countersigned by the transport pool staff of UPEIDA on regular intervals. The kilometers covered by vehicle shall be provided in the bill of the contractor. UPEIDA authorized personnel shall have the right to inspect the logbook(s) at any time.
4. **Legal & Statutory Compliance:** Bidders are requested to comply all legal & statutory requirements like valid PF Registration, ESI Registration, Labor license etc. If the appropriate authorities raise any such requirement/claim/challan, the bidder will have to fulfill all requirements for which no financial burden shall be passed on to UPEIDA.
 - a. The full burden will have to be borne by the bidder. Pollution norms, Motor Vehicle Act, GST etc. as may be applicable to him. The vehicle should have valid Ambulance permit issued by R.T.O. The ambulance should have valid Registration, Fitness Comprehensive Insurance (including third party, property and damage coverage), and permit and exhaust emission certificate etc. Any other requirement stipulated by the statutory authorities from time to time. The vehicle must be comprehensively insured for driver, passengers & the third party for the period of the contract
 - b. Original documents to be submitted by the contractor as and when it is required by UPEIDA
 - c. Drivers should have valid & suitable driving license.
5. A plate indicating “ON UPEIDA DUTY. The driver should be well dressed in uniform and they should be well mannered and courteous.
6. In case a road accident occurs it shall be the total responsibility of the contractor to deal with the Police and administrative/legal authorities, affected parties, staff deployed, courts etc. UPEIDA shall assist the Contractor if required. The staff deployed (Driver / Conductor etc.) on vehicle should be insured by the contractor.
7. Mobile phone to be provided by the contractor to the drivers to have instant communication. The expenses in this regards, will be borne by the contractor.

Annexure “D”

8. The Bidder qualifies for the contract, shall have to maintain an office in Lucknow along with a responsible and empowered person who shall remain available during all the days of the year. The office shall be accessible by road. The office shall be equipped with telephone/ mobile/e-mail facility. Non compliance can result in cancellation of the contract if required.
9. Contractor to ensure that all precautions are taken for safety of his employees and equipment.
10. The staff deployed should be insured by the contractor.

GENERAL TERMS & CONDITIONS OF CONTRACT

Tenders are invited for Hiring of Four Ambulances –Tata winger/ Force Traveller/Maxi Van or Equivalent High roof model, 2017 Model or later, AC with Heater with Advanced Category of Life Support Equipments.

01. Minimum fix payment for running of 3500 KM per month shall be ensured (including AC and non AC operation). However if the minimum fixed Kms exceeds because of operation, the extra kms shall be paid @ 10% higher rates than the quoted rates. The assured minimum KM are subjected to monthly running of the Ambulance, otherwise minimum assured KM will be given on prorata basis. The unutilized prescribed running of 3500 KM shall carry forward to the next month. This condition is however subjected to satisfactory fulfillment of all other terms & conditions. The billing period will begin from the 1st day of a calendar month.
02. **Payment Terms:-** Payment shall be made on monthly basis within 10 days after completion of the month. GST shall be payable extra as applicable.
03. **Penalty/ LD:** In case of breakdown of the ambulance on any day, another ambulance will have to be provided immediately. In case of failure to provide another ambulance, a penalty @ Rs.1000/- per day will be imposed and at the same time cost of hiring the alternate ambulance will be charged to the contractor's account. This will be allowed only for maximum 15 days in a year, after which management reserves the right to terminate the contract.

In case of Ambulance absent for reporting for duty a penalty of Rs. 1000/- per day will be imposed. Ambulance should have cleaned & ironed white seat covers. In case of failure to do so, UPEIDA will get the same prepared and deduct the amount from the bills apart from recovering a penalty of Rs.100/- .

If the contractor is not able to provide the ambulance originally offered for a continuous period of 10 days without prior intimation and acceptance, UPEIDA reserve the right to terminate the contract and to take appropriate action against the contractor.
04. **Delivery of Ambulances:** - The Ambulances will be delivered within 1 months of release of work order.
05. **Earnest Money Deposit (EMD):** Offers shall be accompanied with **Earnest Money Deposit (EMD)** of Rs. 40,000/- (Forty thousand only) through EFT. Offers without EMD shall be liable to be rejected. The EMD shall be refunded to the unsuccessful bidder(s) after award of work as per works policy by UPEIDA and acceptance by the successful bidder. The EMD of selected bidder shall be returned after the submission of security deposit and signing of the agreement by the selected bidder.

Annexure “E”

EMD deposited by the bidder will be forfeited as per Tender Documents if:

- a. After opening the tender, the bidder revokes his tender within the validity period or increases his earlier quoted rates. The bidder does not commence the work within the period as per LOI / Contract.
- b. In case the LOI / contract is silent in this regard then within 15 days after award of contract.

06. **Security Deposit (SD)**: Security deposit @ 25000 per vehicle will be collected from the successful bidder **before start of the work** in the form of either EFT or Bank Guarantee. The S.D will be refunded to the contractor after satisfactory completion of the work and on production of no dues certificate. In case of non-satisfactory performance of the contract, UPEIDA shall have a right to cancel the contract & forfeiting the security deposit.

07. Diesel Price Variation Clause:

- a. The rates agreed between UPEIDA and the contractor will remain firm during the period of contract. However, the rates will increase / decrease by 30% of the percentage increase / decrease in the retail price of diesel, prevailing on the date of tender opening (Techno-Commercial Bid). Any increase / decrease so allowed to the contractor will be extra / less and form the part of basic rate. This increase / decrease will be done only monthly basis as under.
- b. The retail sale price (RSP) of diesel applicable for Lucknow District, will be the basis for calculation of price change. Due to introduction of Dynamic pricing the rates of diesel vary on daily basis, the percentage change of diesel rates as compared to base rate will be computed on daily basis. The avg % change will be calculated for the entire month. This avg % change will be used for computing the increase in the rates.
- c. Percent increase / decrease in rate shall be 0.30 times of percent increase in average RSP of diesel w.r.t. Base rate indicated in the tender.
- d. Example : If the RSP of diesel are as following :

08. Finance department on satisfactory compliances of stamp duty charges, applicable taxes and duties, Security deposit amount etc, shall make payment after deduction of TDS. If the bill is not delayed, then the payment shall be made on 10th of the following month. Monthly Bills will have to be submitted along with a copy of logbook to the concerned authority. Certified bill will be routed for payment to Accounts department for payments.
09. Successful bidder will pay the Stamp Duty on Security Deposit as per Government rules.
10. For Ambulance the ordering / contract will be finalized on lowest technically qualified bidders only. The bidders quoting the lowest price shall be considered for ordering subject to price reasonability & techno-commercial suitability.
11. The driver of the Ambulance should be well behaved and courteous with the patient and their attendant / family members / relatives. He should display restraint and wisdom in dealing with excited passengers. In case of misbehavior by the driver, a suitable penalty can be imposed for each occasion. In case there are multiple repetitions with a particular driver, he will have to be changed.
12. The bidder will have to provide two pairs of uniform to each driver and one pair of black shoes. The shirt should have a label showing the name of the Firm on the left and a name plate pinned on the right side of the shirt showing the name of the driver. The driver will have to be provided with a mobile phone. He will keep the mobile phone charged and in fully operative condition.
13. The contact person mentioned in Annexure-G of this bid will have to meet the Hospital Incharge / Concerned officer of UPEIDA at least once every fortnight for obtaining feedback about the operation of the ambulance. The instructions issued by the Hospital Incharge / UPEIDA executive will be noted down by the contact person in Two Copies, one each for the contractor and UPEIDA.
14. In case the vehicle goes out of U.P. State on UPEIDA duty, the service provider has to obtain road permit for the same. Expenditure incurred on this account shall be reimbursed along with the payment of bill on documentary proof.

Annexure "E"

15. The Ambulance will have to be maintained by the contractor in good running condition which includes at least the following:
 - a. Minimum noise of engine and body while running;
 - b. Tyres with proper treads;
 - c. Inflated Stepony; Working headlights, tail lamps, indicators, speedometer, milometer, temperature indicator etc; Proper paint on the outside; Good condition of bumpers;
 - d. Upholstery in good condition including washed and ironed white seat covers;
 - e. Proper locking of all doors;
 - f. Proper closing and opening of all windows;
 - g. Dusting of dashboard, rear board, matting, windscreen, windows and body.

16. During out station trips, cash for fuel/driver's personal expenditure, other State permit charges etc. will have to be provided in advance by contractor

17. No unauthorized person should be allowed to travel in the Ambulance when on UPEIDA official duty. Failure to comply with this provision can result in non-payment of the trip.

18. **ARBITRATION/ JURISDICTION:** All disputes arising in connection with the contract shall be settled by mutual consultation. If no agreement is reached the dispute shall be settled in accordance with the provisions of the Arbitration and Conciliation Act, 1996(Latest applicable) and the rules made there under. The dispute shall be referred for arbitration to any arbitrator to be appointed by the Head of the Unit. The award of the arbitrator shall be final and binding on both the Parties. The venue of the Arbitration shall be Lucknow. Any matter of dispute arising out of or in connection with this contract shall be under jurisdiction of Lucknow court only.

19. **SUSPENSION:** UPEIDA reserve the right to suspend performance of any or all of its obligations under the contract. Such notice shall specify the obligation of which performance is to be suspended, the effective date of suspension and the reasons therefore. The contractor shall there upon suspend performance of such obligation until ordered in writing to resume such performance by the same authority that ordered for suspension.

Annexure “E”

20. The Contractor has to make an agreement with UPEIDA in the format prescribed only on Rs. 100/- Non-Judicial Stamp Paper.
21. The Contractor shall compensate UPEIDA for any loss or damage to the plant /property, material of UPEIDA due to his worker's / representatives' negligence or otherwise during execution of work contract.
22. The Contractor shall get the character & antecedents of his own drivers verified from police and intimate the same to the management. Before deploying them to work.
23. Government taxes, Duties, Surcharges including service tax shall be deducted at the prevailing rates from the contractor's bill. These should be included in the rate quoted and no reimbursement of the same shall be admissible.
24. The payment of EPF, ESI and gratuity element, if any should be paid by the contractor.
25. Responsibility for damage if any to the Govt. property/individual or third party in case of accident will rest with the contractor.
26. During duty hours, the driver will not consume Intoxication/Alcoholics drink.

Special Conditions

Annexure “F”

1. The vehicle used for ambulance service should be: Hiring of Four Ambulances –Tata winger/ Force Traveller/Maxi Van or Equivalent High roof model, 2017 Model or later, AC with Heater with Advanced Category of Life Support Equipments. The vehicles should be registered in the name of bidder only. The Ambulance shall be operated by Diesel only. The contractor should pay necessary taxes and other insurance payment and carry out exhaust emission test (once in six month). All the connected documents should be kept alive during the contract period.
2. The fuel tank should be always kept full and at any point of time, the level should not be less than 50% of tank capacity.
3. UPEIDA official shall carry out inspection of Ambulance offered and their decision regarding acceptance and rejection is final.
4. 24 hours availability of the ambulance should be ensured at Agra-Lucknow Expressway for any emergency cases at any time. The ambulance shall be deployed at Agra-Lucknow Expressway. The ambulance should work on all Sundays, all local and National holidays, i.e. it should work throughout the year without any break.
5. Minimum 3 drivers (for 3 shifts) should be operated in 24 hours continuous service with mobile phone facility to contact in emergency and the shift timing will be 0700hrs. to 1500hrs, 1500hrs. to 1100hrs., and 1100hrs. to 0700hrs.
6. During the contract period UPEIDA reserves the right to terminate the contract without assigning any reason by giving 30 days’ notice to the contractor.

PRE- QUALIFYING REQUIREMENT

Financial criteria

1. The Bidder shall have minimum average annual turnover of Rs 50 Cr during last three financial years starting from 2014-15
